	Hospitality Terms & Conditions		
1.	DEFINITIONS		
	In these terms & conditions the term 'customer' means any person, firm or company who has made application for and who has been granted hospitality places at either Brands Hatch, Donington Park or any other event offered by Starting Grid Ltd. (The organiser)		

2.	
	Upon acceptance of the hospitality allocation by the organiser there shall be a contract between the organiser and the customer to which these terms and conditions shall apply.

3.		PAYMENT
	3.1	Payments must be made in accordance with the terms and methods set out below :- 20% of full payment on application, 80% payment 30 days prior to the event.
	3.2	In the event the customer fails to meet any such payment obligations (whether as to the amounts or date of payment) then the organiser reserves the right to cancel its contract with the customer and to resell or reallocate the places allocated to the customer and the provisions of paragraph 4 below relating to cancellation charges shall apply.

4.		CANCELLATION
	4.1	If the customer wishes at any time prior to the event to cancel or reduce the numbers allocated to them, then written notice of such wish, stating the reasons for such cancellation or reduction must be given to the organiser by recorded delivery post. For the avoidance of doubt the organiser shall not be obliged to accept the customers notice of cancellation or reduction. The date of cancellation shall be the date the organiser notifies the customer that it accepts the customers notice.
	4.2	In the event that the organiser accepts the customers notice of cancellation or reduction of numbers, or in the event that the organiser terminates the contract with the customer for whatever other reason, the organiser shall have the absolute discretion (but without prejudice to any other right or remedy available to the organiser and without being under any liability to refund or reduce any payments due under these terms and conditions) to reallocate or resell the hospitality places allocated to the customer and to apply the following cancellation charges:
	4.3	Time of cancellation occurring prior to the commencement of the event.

4.4	In any case deposit of 20% (plus VAT) is non-refundable
4.5	More than 30 days 20% of total cost (plus VAT)
4.6	Less than 30 days 100% of total cost (plus VAT)
4.7	The customer hereby acknowledges that the above amounts represent reasonable compensation for the costs incurred by the organiser as a result of the customer cancellation and that they do not represent a penalty.

5.	REDUCTION OF GUESTS
	In the event the customer notifies the organiser in accordance with paragraph 4 above that they wish to reduce the numbers of their bookings, then the organiser shall be entitled to resell or reallocate such places and to apply the scale of cancellation charges set out in paragraph 4 above to the total cost according to the amount by which the original customer numbers allocated is reduced.

6.	EXCLUSION OF PERSONNEL
	The organiser reserves the right in its absolute discretion to exclude or remove from the hospitality facility any person whose presence is or is likely to be undesirable and the organiser may exercise such right notwithstanding that any such person is the employee, agent or client of the customer or otherwise in any way connected or associated with the customer.

7.	UNDESIRABLE ACTIVITIES
	If it appears to the organiser that the customer may be engaged in activities which are deemed to be contrary to the best interests of the event or which appear unethical or to be in breach of the law, the organiser may, without being under any liability to refund or abate any charges paid or due herein, cancel any allocation of places which may have been made to the customer and require them forthwith to vacate the hospitality facility allocated to them and refuse the customer the right of entry.

8.	COMPLIANCE WITH REGULATIONS
	The customer shall abide by and observe all requirements, laws, rules and regulations whether imposed by the organiser, the proprietor or managers of the premises, building or any municipal or other competent authority.

9.		LIMITATION OF LIABILITY
	9.1	The organiser, its employees or agent shall not be liable for any loss, theft, damage or injury to persons or property suffered by the exhibitor, its employees or agents.
	9.2	Information given by the organiser about the event is accurate to the best of its knowledge but does not constitute any warranty or representation by the organiser and therefore any mistake or omission will not entitle the customer to cancel their booking.

10.	INDEMNITY
	If the customer is a limited company, the directors of the exhibitor hereby undertake to fully and effectually indemnify and keep indemnified the organiser, its employees, agents and contractors against all costs, claims, demands, proceedings and losses for which the organiser or its employees, agents and contractors may become liable in consequence of damage or injury to any person or property occasioned by or arising out of the act, default or negligence of the customer, its employees or agents or any other person under its direction or any independent contractor engaged by it.

11.	1	ASSIGNMENT
	9	The customer shall not be entitled to assign or delegate to a third party, any rights or obligations of the customer arising under these terms and conditions. The organiser shall be entitled to assign the benefit (subject to the burden) of its contract with the customer without notice to or consent from the exhibitor.

12.	ENTIRE AGREEMENT
	These terms and conditions contain the entire agreement between the organiser and the customer and may not be changed orally, but only in writing signed by a duly authorised representative of the party against whom enforcement of any waiver, change, modification or discharge is sought.

13.	GOVERNING LAW AND JURISDICTION
	These terms and conditions shall be construed in accordance with English law and the exhibitor hereby submits to the non-exclusive jurisdiction of the English courts.  Starting Grid LTD, Hammonds Barn, London Road, Burgess Hill, West Sussex, RH15 9QJ
